The neighborhood associations support the cost of these gardens (\$500 each) and advertise the program; average cost per household is \$350. The board should tell Metro Blooms in November how many gardens we want to make available to our families.

Staff Report-Kate Roarty

In Luke's absence, Kate summarized his report.

- --We asked Metro Transit about the bus shelter at 42nd & Bloomington (NE corner). We are told that the stop is little used,
- so Metro Transit isn't interested in fixing the shelter. We'll look for more information, and keep this spot on our agenda.
- --Crosswalks at Bloomington and 40th & 41st Streets would enhance safety in the neighborhood.
- --Public Works is looking into whether the Bancroft School corners at 39th Street meet their criteria for stop signs.
- --Luke found 2 firms interested in upgrading our website, MN Tech Co-op and The Site Edge. They share similar cost estimates. We'll ask him questions in November.
- --BNA could set up a code compliance program for households, similar to our home improvement programs. We might also establish a facade improvement program for concerns outside the business nodes we administer.
- --No hurry yet to find a home for our NRP funds. Luke believes we have until spring.
